Sir,

I am directed to say that incontinution of the letter No. 4/7/97/FPI/8781 dated 20.7.98 on the subject cited above, The Governor of Punjab is pleased to grant House Rent Allowance at the rate of 5% of their pay to such Punjab Government employees, who have not been allotted Government accommodation but were entitled to rent free accommodation. This allowance shall be in addition to the normal House Rent Allowance, admissible at the place of posting. This is subject to the condition that the residence hired by the employee is in close proximity to his place of posting or at a place as may be specifically permitted by the competent authority.

- 2. The decision contained in this circular letter shall be effective from 1.12.2011.
- 3. The remaining conditions for the grant of House Rent Allowance in lieu of rent free accommodation will be applicable as per instructions issued from time to time by the Finance Department.
- 4. Punjabi version of these orders shall follow in due course.
