Subject: Grant of Higher Education Allowance.

Sir,

I am directed to invite a reference to the subject cited above and to say that after careful consideration of the recommendations of the Fifth Punjab Pay Commission, the Governor of Punjab is pleased to decide that P.C.M.S. doctors who have attained postgraduate qualification such as M.D. or M.S. shall be entitled to one additional increment on the basic pay admissible to them. A P.C.M.S. doctor, who attains postgraduate qualification after the date of issue of these orders, shall also be entitled to the benefit of additional increment admissible under these orders. However, the employees who have already received incentive for higher qualification, in any form, shall not be entitled to benefit admissible under these orders.

2. The additional increment admissible under these orders shall be calculated as per rule 9 of the Punjab Civil Services (Revised Pay) Rules, 2009 and the normal date of increment of the concerned employee shall remain unchanged.

3. These orders shall be deemed to have come into force with effect from the 1st December, 2011 and shall be applicable prospectively and there shall be no element, whatsoever, of retrospectivity in this regard and there will be no question of payment of arrears or of fixation of pay on notional basis from any pervious date.
