3. The Special Allowance admissible under these orders shall be in addition to the Secretariat Allowance admissible to these categories of employees in terms of Government letter No.3/10/10-5FP2/459-64, dated the 13th October, 2010.

4. These orders shall come into force w.e.f. 1.12.2011.
