Grant of a Special Grade Pay to certain categories of employees.

Sir,

I am directed to invite a reference to the subject cited above and to say that the Governor of Punjab is pleased to decide that all the Government employees who are working on the posts having pay scales in Pay Band-1, Pay Band-2 and Pay Band-3, as shown in the Schedule appended to the Punjab Civil Services (Revised Pay) Rules, 2009, shall be entitled to a Special Grade Pay of Rs. 150 with effect from 1st December, 2011, subject to the following conditions:-

- (i) The Special Grade Pay admissible under these orders shall be sui generis and shall not be merged in the Grade Pay attached with the Pay Band of the relevant post.
- . (ii) The Special Grade Pay admissible under these orders shall be treated as pay for all intents and purposes.
- (iii) The Special Grade Pay granted under these orders shall not be taken into account for
 classification of the Group of an employee.
- (iv) The Special Grade Pay admissible under these orders shall not be taken into account for the purpose of entitlement of Travelling Allowance/Daily Allowance.
- (v) The Special Grade Pay shall NOT be admissible to those Government employees who have been granted, or shall be granted, enhanced scales of pay over and above the pay scales admissible to them under the General Conversion Table given in the Schedule appended to the Punjab Civil Services (Revised Pay) Ruies, 2009, either on the recommendations of the Fifth Punjab Pay Commission of otherwise, except Police Constable. Minimum benefit of special grade pay of Rs. 150 snall be ensured.
- (vi) This benefit shall be admissible only to employees in service as on 1st December, 2011 and shall Not extent to persons appointed thereafter.
