

- 2. The Conveyance Allowance mentioned above shall also be admissible to the corresponding posts of the Local Fund Accounts wing of the Department of Finance.
- Those employees who have been allotted Government vehicle shall not be entitled to Conveyance Allowance.
- 3. These orders shall come into force with effect from the 1<sup>st</sup> December, 2011.
- 4. The Punjabi version of these orders will follow in due course.
