Subject: - Revision of pay scales and grant of designation of Assistant Engineers under the Career Progression Scheme applicable to the Junior Engineers.

Sir/Madam.

I am directed to invite a reference to Government I.D. No. 7/56/99-5PPI/8014, dated 27th June, 2000 addressed to all the Financial Commissioners/ Principal Secretaries and Administrative Secretaries, to Government, Punjab and Government Notification No.5/10/09-5FP1/207, dated 27.5.2009, and to say that the Governor of Punjab is pleased to decide that the scales of pay of the Junior Engineers working in different departments of the State Government shall stand further revised as under with effect from the 1st day of December, 2011:--

2. It has been further decided that on grant of higher pay scale after completion of regular service of ten years, a Junior Engineer shall also be given the designation of Assistant Engineer.

3. The pay in the above mentioned revised scales effective from the 1st December, 2011, shall be fixed prospectively and there shall be no element, whatsoever, of retrospectivity in this regard and there will be no question of payment of arrears or of fixation of pay on notional basis from any previous date.

4. The procedure prescribed vide I.D. No. 7/56/99-5PPI/8014, dated 27th June, 2000 of the Department of Personnel, for assessment of work and conduct of the concerned employee for grant of higher pay scale and designation of Assistant Engineer on completion of the prescribed span of

regular service and the remaining conditions for grant of benefit under these orders shall remain the same. However, the employee concerned shall NOT be required to pass any departmental examination for grant of benefit under these orders.

5. The employees governed by these orders shall not be entitled to any benefit under any other Assured Career Progression Scheme issued by the Government.

6. It has been further decided that on completion of regular service of twenty-five years, a Junior Engineer (designated as Assistant Engineer) shall be entitled to an additional increment as per the rate of annual increment prescribed in rule 9 of the Punjab Civil Services (Revised Pay) Rules, 2009. On grant of such additional increment, the normal date of next annual increment of an employee shall not be changed.

7. These orders are issued with the approval of the Hon,ble Chief Minister, Punjab in accordance with the decision of the Council of Ministers in its meeting dated 2nd November, 2011.

8. The necessary amendments in the rules will be made in due course.
