I am directed to invite a reference to Punjab Government Notification No. 5/10/09-5FP1/207, dated 27.5.2009 and to say that the Governor of Punjab is pleased to decide that the pay scales of the following categories of posts shall stand further revised as under with effect from the 1<sup>st</sup> December, 2011:-

The pay in the above mentioned revised scales effective from the 1st December, 2011, shall be fixed prospectively and there shall be no element, whatsoever, of retrospectivity in this regard and there will be no question of payment of arrears or of fixation of pay on notional basis from any previous date.

3. It has been further decided that the Deputy Director (Statistics) shall be allowed a Special Allowance of Rs. 2000 (Rupees Two thousand only) per month.

4. The employees working on the above noted posts shall not be entitled to any Special Grade Pay in terms of Government circular letter No.5/10/09-5FP1/807, dated 14th November, 2011.

5. The necessary amendments in the rules will be made in due course.
