

Copy of Punjab Government circular letter No. 7/124/2001-5PPI/18350, dated 7th December, 2001 from the Department of Personnel addressed to all the Heads of Departments etc. in the State of Punjab.

Subject :- Recommendations of the 4th Punjab Pay Commission Implementations of Assured Career Progression Scheme for categories where there is a direct recruitment in the existing pay scales of Rs. 2200-4000 as on 31st December, 1995.

"Placement in higher scale and proficiency Steps up under this policy shall be granted only to those employees whose overall service record as adjudged as 'good'.

Subject :- Ban on contractual/Daily Wage Appointments.

The Department of Finance, Directorate of Institutional Finance and Banking and Public Enterprises, vide circular letter No. 9/134/2001-FD(BPE)SO-III/1261-1300 dated 1.6.2001 on the subject has issued directions regarding Contractual/Daily Wages appointments. Stress was on the following issues :-

- 1) Henceforth, no contractual/daily wage appointments shall be made by any Corporation, Boards or Apex Cooperative Institutions and their subsidiaries without prior permission of the Finance Department. Wherever, such powers are vested with the functionaries of the PSUs of Apex Cooperative Institutions through the Bye-Laws, the said Bye-Laws may be modified forthwith.
