Subject:- Regarding extension in service to the employees beyond the date of retirement on superannuation.

Sir/Madam,

I am directed to invite your attention to the instructions issued vide this department's letters No. 22/2/2012-3FP2/475 dated 08.10.2012 and No. 22/2/2012-3FP2/471 dated 20.09.2013 whereby extension of two years in the service duration of all classes of employees, if so opted by the employee, was allowed subject to certain conditions.

- 2. The Government of Punjab, Department of Finance (FP-2 Branch) vide its letter No. 22/2/2012-3FP2/ 257, dated 30th October, 2015 issued clarifications with reference to optional extension in service duration of all classes of employees.
- The Government of Punjab, Department of Finance (FP-2 Branch) vide its letter No. 10/80/2016-3FP2/210 dated 22.05.2017 read with letter No. 10/80/2016-3FP2/ 1383693/1, dated 1st January, 2019 issued further instructions extending the applicability of the aforesaid instructions to the employees with disability belonging to all classes.



- 4. The Government of Punjab, after careful consideration, has reviewed the existing Rule 3.26(a) of Punjab Civil Services Rules Volume 1, Part 1 and has amended this Rule 3.26(a), which reads as follows:-
  - "3.26 (a) Except as otherwise provided in this rule, the date of retirement of a Government employee shall be as follows, namely:-
  - (i) fifty-eight years in the case of Group 'A', 'B' and 'C' employees; and
  - (ii) sixty years in the case of Group 'D' employees:

Provided that if the State Government is of the opinion that it is necessary and expedient so to do in public interest, the service of a Government employee or a class of Government employees may be extended and governed in the following manner, namely:-

- (A) the Government employees, belonging to Group 'A', 'B' and 'C' service, who are working on the second year of optional extension in service i.e. who have already attained the age of fifty-nine years and who are availing the second year of optional extension in service, or whose second year of optional extension in service is scheduled to start from the 1<sup>st</sup> day of April, 2020, shall retire on the 31<sup>st</sup> day of March, 2020, and the Government employees belonging to Group 'D' service and the Persons with Disabilities who are working on the second year of optional extension in service after attaining the age of sixty-one years, or whose second year of optional extension in service is scheduled to start from the 1<sup>st</sup> day of April, 2020, shall retire on the 31<sup>st</sup> day of March, 2020;
- (B) the Government employees belonging to Group 'A', 'B' and 'C' service, who are working on the first year of optional extension in service i.e. who have already attained the age of fifty-eight years and who are availing the first year of optional extension in service, or whose first year of

optional extension in service is scheduled to start any time till the 1<sup>st</sup> day of September, 2020, shall, upon opting for such extension, retire on the 30<sup>th</sup> day of September, 2020, and the Government employees belonging to Group 'D' service and the Persons with Disabilities, who are working on the first year of optional extension in service after attaining the age of sixty years, or whose first year of optional extension in service is scheduled to start any time till the 1<sup>st</sup> day of September, 2020, shall, upon opting for such extension, retire on the 30<sup>th</sup> day of September, 2020; and

the Government employees belonging to Group 'A', 'B' and (C) 'C' service, who, after attaining the age of fifty-eight years are on the first year of optional extension in service and whose first year of optional extension in service is scheduled to end before the 30<sup>th</sup> day of September, 2020, shall retire in accordance with clause (d), when he completes the first year of optional extension in service, and the Government employees belonging to Group 'D' service and the Persons with Disabilities, who, after attaining the age of sixty years are on the first year of optional extension in service and whose first year of optional extension in service is scheduled to end before the 30<sup>th</sup> day of September, 2020, shall retire in accordance with clause (d), when he completes the first year of optional extension in service:

Provided further that under exceptional circumstances, if the State Government considers it necessary and expedient so to do in public interest, it may extend the service of the Government employee beyond the aforesaid limit, for the reasons to be recorded, in writing."

The above said amended Rule stands notified vide Notification No G.S.R. 21/Const./Art.309/Amd. (9)/2020. dated 02.03.2020.



6. Accordingly, the instructions issued by Government of Punjab, Department of Finance (Finance Personnel - 2 Branch) vide letter No. 22/2/2012-3FP2/471 dated 20.9.2013 shall cease to be in operation w.e.f. 31.3.2020. Similarly the instructions issued vide No. 10/80/2016-3FP2/210 dated 22.05.2017 read with letter no. 10/80/2016-3FP2/1383693/1 dated 1.1.2019 providing for extension in service to Persons with disability (PWD) employee, to the extent of providing second year optional extension, shall cease to be in operation w.e.f. 31.3.2020 to the extent of second year optional extension.

The instructions issued by the Government of Punjab, Department of Finance (Finance Personnel – 2 Branch) vide its letter No. 22/2/2012-3FP2/475 dated 8.10.2012 shall cease to be in operation w.e.f. 30.9.2020. Similarly, the instructions issued vide No. 10/80/2016-3FP2/210 dated 22.05.2017 read with letter no. 10/80/2016-3FP2/1383693/1 dated 1.1.2019 providing for extension in service to persons with disability (PWD) employees, to the remaining extent of providing first year optional extension, shall cease to be in operation w.e.f. 30.9.2020.

- 7. The competent authorities shall review the orders of extension in service, wherever issued, in accordance with the above amended Rule.
- 8. Meticulous compliance of these instructions shall be ensured and any laxity or deviation from these instructions shall be viewed seriously.
- 9. Punjabi version of these instructions shall follow in due course.
